IMPORTANT: DNA TESTING PAYMENT POLICY

All DNA tests are payable in full up front by the client prior to ordering the test kit.

This ensures accurate test requests and helps avoid delays in processing your order. Shipping fees (when applicable) will be provided at the time of ordering (estimated \$9).



TIME OF PAYMENT

- Payment is due at the time of service for all drug testing collections.
- Non-DNA services are usually payable at the time of collection, unless prior arrangements have been approved.



EMPLOYER ACCOUNTS

- Approved employer accounts may be invoiced according to agreed terms.
- Payment terms (Net 15 or Net 30) will be outlined in your account agreement.
- Accounts must remain current. Services may be paused if an account becomes past due.



ATTORNEY ACCOUNTS

- Attorney accounts may be invoiced based on approved terms.
- Payment is expected within the agreed period.
- Fees will be outlined in your account agreement.



CANCELLATIONS & RESCHEDULING

- Please provide at least 24-hour notice to cancel or reschedule an appointment.
- Cancellations with less than 24-hour notice or no-shows may be subject to a cancellation fee.
- Fees will be determined based on the service and time committed.



RETURNED PAYMENTS

- A returned payment fee of \$35 will be charged for any returned or declined payment.
- The balance, including the returned payment fee, must be paid in full before additional services are provided.



REFUND POLICY

- Due to the nature of our services, refunds are not provided once a collection has been completed or a test kit has been ordered.
- Refunds (if approved) will be issued at the discretion of Beacon on a case-by-case basis.



LABORATORY & SHIPPING FEES

- Laboratory and shipping fees are determined by the testing laboratory.
- These fees are in addition to Beacon's collection fee.
- Shipping fees for DNA tests (when applicable) will be provided at the time of ordering (estimated \$9).
- Expedited shipping or rush processing may incur additional charges set by the laboratory.
